Clinical Studies, Scientific

Naticol® Marine Collagen Peptides Clinical Study Skin

Results of two dermoclinical studies conducted by CPCAD, Nice hospital, revealed that users of Naticol® fish collagen peptides experienced improvements in skin beauty. Other scientific studies also suggested that ingestion of Naticol® may present benefits in other health areas, such as weight management.

A daily oral administration of 2,5g Naticol ® (fish collagen peptides) reduces facial wrinkles (Crow's feet/ perioral wrinkles), improves significantly skin firmness, skin complexion homogeneity and skin radiance. These are the most recent results obtained from a clinical study conducted by CPCAD/ Hospital of Nice (France) on assessment of Naticol® effects on skin aging signs.

In this double blind, randomized, against placebo study, Weishardt has evaluated the effects of its specific fish collagen peptides (Naticol ®) on skin aging signs, after an oral intake of 2,5g/day, for 8 and 12 weeks.

Clinically proven efficacy this study was carried out on 95 mature women mean-aged 55 years old, randomized in

parallel groups to receive a once a day 2,5g dose of specific fish collagen peptides (Naticol ®) or the placebo for 12 weeks. Skin biomechanics and clinical assessment of the facial wrinkles (crow's-feet and perioral) and skin complexion homogeneity were evaluated.
